Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of a Unitary Constitution.

Recruitment and Appointment of Trustees

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The Interim Moderator, who is a member of the Kirk Session, was appointed by Presbytery.

Organisational Structure

The following Committees have been set up, and meet regularly: Finance; Property; Fellowship; and Safeguarding; all reporting to the Kirk Session. At least one member of each committee is an Elder, the other members being drawn from the wider congregation and who have the appropriate skills for that committee. The Kirk Session meets five times a year, and is responsible for the spiritual, and all other affairs within the church.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

The church has a service of worship each Sunday at 10.15am, followed by an informal Communion Service on the second Sunday of the month. On-line Services have been available for those who do not feel comfortable with returning to physical Church. It provides Christian education and activities for children aged five via the local primary schools. It organises various social activities, such as quizzes, coffee mornings, charity evenings, and meals, through the year.

The church organises various collections of money and goods for local and international charities, such as Christian Aid, Poppy Scotland, Blythswood Care, RNLI, Mikeysline, Black Isle Cares, Linda Norgrove Foundation, the DEC Turkey/Syria Appeal, and debra, .


Achievements and Performance

The congregation shared study groups at Lent and Advent with members of Knockbain Church of Scotland. The Congregation have sent 40 boxes of toiletry items (approx. value £600), plus donated £44.26 towards their distribution, to Blythswood Care for distribution to the homeless, and about 30 large bags of non-perishable food to the foodbank.

Financial Review

The principal source of income is from the weekly offerings, gift aid, open plate and FWO, (see attached chart). Fundraising for nine charities – the DEC Turkey/Syria Appeal, Blythswood Care, Christian Aid, Poppy Scotland, debra, Linda Norgrove Foundation, RNLI, Mikeysline, and Black Isle Cares with £4,749 being raised.

Reserves Policy

It is the Trustees' policy to hold reserves of approximately six months expenditure including designated funds. At the year end the Church held unrestricted cash funds of $\pounds 46,731$ of which $\pounds 19,004$ had been designated for fabric fund.

Statement of Trustees' Responsibilities

Independent Examiner's Report to the Trustees of Killearnan Parish Church

I report on the accounts of the charity for the year ended 31 December 2023 which are set out on pages 6 to 11.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.

The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.
